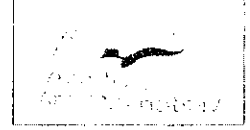

Sir,

The Chief Secretary, Delhi has reviewed the status of court cases relating to service matters including pension cases pending in various department of GNCT of Delhi. It has been observed that there are pending cases of Service matters including pension cases in sizeable numbers (copy attached) in various departments of GNCT of Delhi. The delay in disposal of pension cases causes not only mental harassment and agony to retired Govt. Servants but compel them to face financial hardship even after their having rendered a long service to the GNCT of Delhi.

The Chief Secretary, Delhi is of the view that such a sizeable pendency of pension cases is highly undesirable and against the service ethos. The Chief Secretary, Delhi has desired that all the pending pension cases shall be decided by the concerned administrative departments in time bound manner by 31st July 2022 positively.
