Further, the cases in which currency of penalty is in progress will be considered after the completion of currency of penalty. The promotion order is subject to outcome of any change in seniority/any other issues pending in various court cases.

Their inter-se-seniority on promotion shall be the same as their relative seniority in the lower grade from which they are promoted (Table-1).

The officials promoted may exercise option for fixation of pay in terms of FR 22 I (a) (i) within one month from the date of joining as Head Warder. However, the officials who have already been granted financial upgradation under Assured Career Progression Scheme/ Modified Assured Career Progression Scheme are not entitled for any fixation benefits now.

The concerned Head of Offices are requested, before issuing final order/taken on strength order/relieving order, to verify that no disciplinary proceeding is pending or any penalty is in operation against the above mentioned officials. If the official is not clear from vigilance angle or any currency of penalty is there as on the date or has resigned/expired etc., the same may be brought to the notice of Superintendent-I(PHQ) immediately.

Consequent upon their promotion to the post of Head Warder, above officials shall continue to work physically at their present place of posting and their transfer posting order shall be issued separately.
