

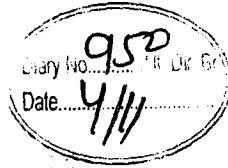

This directorate General under Ministry of Skill Development & Entrepreneurship provides Grant –in-aid to State/UT Governments for implementing the 'Scheme for Integrating Persons with Disabilities (PWD) in the mainstream of Technical and Vocational Education'. The scheme was introduced with the objective of upgrading some of the selected polytechnics to integrate persons with disabilities in the mainstream of technical and vocational education. The scheme envisages each polytechnic to train upto 25 disabled students through formal courses consisting of regular three-year diploma programmes and upto 100 disabled persons each year through non-formal courses consisting of vocational/ skill development programmes. The disabled students are encouraged through provisions like scholarship, supply of books/ educational materials, uniforms, free boarding and lodging etc. At present the scheme covers about 50 polytechnics throughout the country.

Point No. 3 & 4

The RTI is being transferred to DTE, States/UTs implementing the Scheme as the said information is available with them.
